## TERMS AND CONDITIONS OF SALE

**ACCEPTANCE:** No acceptance shall be effective which varies the Terms here of or proposes additional Terms. Any such proposals shall be deemed to be rejected unless expressly approved by us in writing.

**TERMS:** Unless otherwise noted on the face of the invoice, the invoice total amount shall be due in thirty days of the invoice date (NET 30).

**COLLECTION COSTS:** In the event that Filter Supply refers a past due invoice (or any part thereof) to attorneys for collection, the Purchaser agrees to pay all reasonable attorney's fees and all other costs of collections in connection therewith including, without limitation, any attorneys fees in connection with any bankruptcy proceedings, serving any creditors committee or in any capacity in such proceeding, and in connection with any appeal. The Purchaser also agrees to have the case held in a venue of Filter Supply's choosing.

**WARRANTIES:** Filter Supply makes no express warranties with respect to goods sold other than as set forth on the invoice or provided by product manufacturer, and no implied warranties of fitness for particular purpose in connection with the sale of any goods.

**RETURNS:** Returns may be made on all items except special orders and cut goods (i.e. wire, exhaust tubing). Full credit will be given of returned within 30 days of purchase and with copy of invoice. Any items returned after 30 days will be assessed 15% restock fee. Any items returned without copy of invoice will be accepted at the discretion of management.

**QUOTATIONS:** No quotation, estimates or delivery dates furnished by any employee are accepted as binding unless confirmed in writing by Filter Supply.

**RISK OF LOSS:** The risk of loss shall pass to the Purchaser upon delivery by Filter Supply and acceptance (signed invoice) by the Purchaser.
